Individual License Requirements - Biennial mandatory CEUs to maintain Licensure

- 1) 20 hours for 2 years
- 2) 3 of the 20 hours in Universal Precautions/Infection Prevention
- 3) The remaining 17 hours to be in courses related to the practice of electrology by programs, courses, or seminars approved by the Continuing Education Review Committee (CERC) of the AEA 30 days prior to the event. Listings of approved courses: Communications, Ethics, Business, Accounting and Technology and health related subjects such as Diabetes, Dermatology, Endocrinology, Plastic Surgery, Allergies.

Present licensing period is November 1, 2023- October 31, 2025
